

Information regarding a review into China and Hong Kong based conduct

Royal Government of Hokoria

The Royal Office is dedicated to ensuring the safety of government staff and citizens. It's part of our duty as leaders to ensure that we reduce risk where we can, especially when current circumstances could harm citizens. The Royal Territory of Atlantis recently came under the control of the State of Hokoria. Atlantis is surrounded by Hong Kong, a Chinese specially administered province that has once again made headlines following steps to strengthen national security law and give more power to authorities.

After careful review, the Royal Office had concluded that:

- a. There is a potential and serious risk of harm posed against individuals linked to the Royal Government of Hokoria by the Royal Government of Hokoria being anyhow critical of the Hong Kong leadership as a result of national security law.
- b. The Royal Government of Hokoria will be unable to provide direct support for individuals linked to the Royal Government of Hokoria that are located within Hong Kong or mainland China.

As a result, we are responding by:

- a. Introducing a 'Royal Policy for the Safeguarding of individuals located within Chinese territories' that will restrict the Royal Government of Hokoria in how it responds to matters that may pose a risk to individuals located within Chinese territories, including Hong Kong.
- b. Encouraging the use of VPNs by all officials of the Royal Government of Hokoria, especially individuals located within Chinese territories, including Hong Kong, whilst asking for 'consideration' of local laws that could prohibit use of VPNs.
- c. Providing officials and citizens with information and direction that may be useful with moving to foreign nations.



Royal Policy for the Safeguarding of individuals located within Chinese territories

The Government, and all public bodies of the State, should not release any material in an official capacity that is anyway critical of the leadership of Chinese territories as to safeguard individuals located within Chinese territories.

The Royal Office acknowledges that risk towards individuals located within Chinese territories is relatively low.

The Royal Office encourages the Government and all public bodies of the State to speak in a much broader way when discussing matters that relate to the leadership of Chinese territories. Indirect criticism of the leadership of Chinese territories is encouraged.



Royal Office statement for citizens and government officials regarding the use of VPNs (virtual private networks)

The Royal Government of Hokoria is committed to the safeguarding of our citizens and government officials. The internet can be quite a dangerous place, and some uses of the internet can even result in prosecution depending on your region of residence.

We encourage all citizens and government officials to be mindful of the way that they use the internet and be considerate of local laws when using the internet. Additionally, we encourage that all citizens and government officials utilise VPNs (virtual private networks) when using the internet in order to act as an extra layer of protection from bad actors. When using VPNs (virtual private networks), we once again ask for consideration of local laws.



Moving from Hong Kong to the UK

The Department of Exterior Affairs endorse **Migration Yorkshire** as a charitable organisation that supports Hong Kongers with adjusting and moving to the Yorkshire and Humber area. Migration Yorkshire is based in Leeds, a city in West Yorkshire. They offer support for migrants from lots of backgrounds, including Hong Kongers and have a 'welcome programme' as well as many other services such as support with employment, health and wellbeing, housing and learning English.

Hong Kong Aid is an organisation located within London, the English capital, and provides similar services and support whilst being focused specifically on Hong Kongers.

Moving to the UK would require application through the UK government's Home Office. For more information, visit **the UK government's visas and immigration page**. The Royal Government of Hokoria will be unable to provide direct support for seeking asylum and acquiring a visa in the UK, although we may be able to direct Hong Kongers to organisations that can.
